


Certified that the Governing Council of Dharmagiri Educational Trust, Banashankari 2<sup>nd</sup> stage has been registered under Karnataka Education Act 1983 [Karnataka Act 1 1994 Sec 3] on this is 6<sup>th</sup> day of February 2004 to run the following Educational Institution.

The said educational institution has been registered as per Registration of Educational Institution and register of this Office vide Sl.No.72, Page NO.72.




This certificate has been issued subject to the following conditions:

1. This registration is subject to Rule 3[5] [4]
2. The Governing council has to compulsorily follow all the conditions mentioned in rule 4[4].
3. Subject to condition for providing site for school, dimension, building, Lesson aids, furnitures, staff, financial provision etc.
4. The said Educational Institution should not open additional section without the prior permission of the Government.
5. School has to be started in the medium of instruction permitted and the only at the place permitted and there is no provisions at any cost for change of place.
6. The school has to be started and run by the Management for which permission has been accorded and at the place so permitted and in the same name only so accorded.
7. This Educational institution has to follow all the Government orders, rules in force and issued in this regard from time to time all the rules under the Karnataka Educational Act, 1983 [ Karnataka Act NO.1/96] and rules framed under this Act.
8. This High school has been registered as permanent unaided institution as per Government Notification No. ED/75/PMC/95 dated 2.9.1998 and dated 29.12.1998. The Management has to give an undertaking on Rs 10.00 stamp paper giving undertaking on oath before a Notary giving consent letter for non-intention for claiming any grant from the government by the management.



9. Rules under Karnataka Private Educational Institutions [Condition of Appointment, service regulation of Employees] Private unaided primary and second school institutions] Rules 1999 shall be compulsorily followed.
10. The text books prescribed and examination patterns prescribed by the department and Government shall be compulsorily adhered to.
11. First report has to be submitted to concern D.D.P.I for recognition before two months of starting of the school.
12. The ratio of children and teacher has to be assisted as per the rules for each class permitted. Each class shall have minimum admission of 30 and maximum admission 60 and minimum attendance of 25.
13. Shall appoint trained teachers possession required educational qualification prescribed by the Department.
14. All the registered schools shall be covered under recognition and provisional recognition as per sub section 36 – 39 of Article 8 of Karnataka Education Act.
15. The students have to be medically examined every academic year.
16. The security deposits have to be given in the jurisdictional office of DDPI and Management for starting the school by the management.
17. The furnitures, machineries, library books, playground, school building and other facilities required for the school has to be procured within a year as per rules under Karnataka Education Act failing which the registration shall be cancelled.
18. The working hours of the school and calendar shall be complied as per the Departmental rules.

19. The facts regarding the start of the school, the admission records of the students shall be reported to this office before two months of start of the school or registering the school.

In the case the school has been not started not non compliance of any of the condition shall result in cancellation of this order automatically.

20. The school has to provide separate toilet for boys and girls and drinking water facility shall be made available.

21. S.R has to be opened for each teaching / non teaching staff appointed in the school wherein the service particulars of them have to be recorded and maintained as per KCSRs.
